## Instructions for Recipient

Recipient's identification number. For your protection, this form may show only the last four digits of your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN). To complete Form 1099-MISC, use:

• the 2016 General Instructions for Certain Information Returns, and

• the 2016 Instructions for Form 1099-MISC.

To complete corrected Forms 1099-MISC, see the 2016 General Instructions for Certain Information Returns.

To order these instructions and additional forms, go to *www.irs.gov/form1099misc*.

**Caution:** Because paper forms are scanned during processing, you cannot file Forms 1096, 1097, 1098, 1099, 3921, 3922, or 5498 that you print from the IRS website.

**Due dates.** Furnish Copy B of this form to the recipient by January 31, 2017. The due date is extended to February 15, 2017, if you are reporting payments in box 8 or 14.

File Copy A of this form with the IRS by January 31, 2017, if you are reporting payments in box 7. Otherwise, file by February 28, 2017, if you file on paper, or by March 31, 2017, if you file electronically. To file electronically, you must have software that generates a file according to the specifications in Pub. 1220. The IRS does not provide a fill-in form option.
